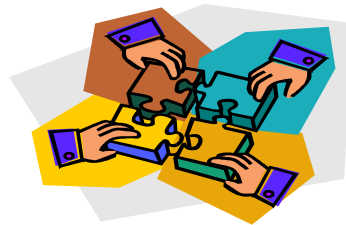

OCC works with community businesses and County procurement staff to provide guidance and information on the utilization of local, small and emerging businesses. Vendor informational meetings, training and vendor fairs are held to provide an opportunity for local, small and emerging businesses to become acquainted with the County's procurement processes. OCC maintains a database of local businesses and certified small and emerging businesses which is available on-line. OCC collaborates with other Interagency Alliance members on certification applicants.

AC accepts certification from other Bay Area transit agencies through the Regional Transit Coordinating Council Minority Affairs Committee (RTCC MAC); and accepts certification by other U.S. DOT recipients such as Los Angeles MTA and CalTrans. AC may accept certifications from other interagency Alliance members on a case by case basis specifically including the required sit visit.

***Certification:*** The Port of Oakland certifies businesses as Local Business Area Business Enterprises (LBABE) and Local Impact Area Business Enterprises (LIABE). LIABE is the cities of Alameda, Oakland, San Leandro, and Emeryville. Minimum certification requirements include: 1. Current and prior year City/County business licenses issued by the city the firm is located in. 2. Firms have a substantial business presence in Alameda or Contra Costa counties for 12 months prior to certification request. 3. Current professional, sellers, contractor license or applicable permit to perform business/service. LIABE firms may also qualify for the Port's Small or Very Small Business Enterprises if revenue criteria is met. The Port of Oakland will collaborate with other Interagency Alliance members on certification applicants. Certification application and searchable database available on the Port's website.
