**NOTICE IS HEREBY GIVEN** that the Alameda County Board of Supervisors will hold a public hearing to consider adoption of two resolutions consistent with the Board's March 24, 2015 motions to approve the application of Altamont Winds Inc. (AWI) to extend for three (3) years, through October 31, 2018, beyond their current expiration date of October 31, 2015, making appropriate Findings of Significant Impacts of the project, adopting a Mitigation Monitoring and Reporting Program (MMRP) and adopting a Statement of Overriding Considerations, and to certify the Supplemental Environmental Impact Report (SEIR) for the project, for 828 turbines owned and operated by AWI with a rated capacity of approximately 85.8 megawatts (MW), located throughout the 14,436-acre Alameda County portion of the Altamont Pass Wind Resource Area (APWRA), in the eastern portion of Alameda County, adjacent to Interstate I-580.

The March 24, 2015 motions, and the resolutions to be adopted at this hearing, also serve to: 1) deny the appeal of Audubon California from the decision of the East County Board of Zoning Adjustments (EBZA) on February 2, 2015 to certify the SEIR, thereby certifying the SEIR; and 2) grant the appeal by AWI from the decision of the EBZA on February 2, 2015 to deny the application, thereby approving the CUP extensions.

**IF YOU CHALLENGE** the County's action in court, you may be limited to only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Board of Supervisors at or prior to the public hearing.

**SAID PUBLIC HEARING** will be held on **Tuesday, May 5, 2015** beginning at **1:00 p.m.**, in the Board Chambers of the Alameda County Board of Supervisors, 1221 Oak Street, fifth floor, Oakland, California.
