- The reserves appear to have a negative balance because the \$1M in one time allocations have not gone to the board yet. HCSA staff further explained that the \$17M figure is the balance at the end of FY 16-17 and it takes the Auditor's office a few months to balance the books and update in the County's AlcoLink system. Roughly \$5M is anticipated to be deposited into the reserves.
