# I. Welcome and Introductions

- Jennifer Chan indicated that the FY09/10 Measure A budget has not yet been reconciled as the final adjustments were just approved by the Board of Supervisors on 11/30; Jennifer indicated that she and Vana Chavez hope to present to reconciled budget at the next meeting.

# **Presentations by Subcommittees**

# Subcommittee 1

- BHCS reports broad and no measurable objectives; testimonials were good, but report was generally poorly written; need to include information from budget reconciliation; include concerns in reports
- Glen Dyer Jail report notes 1,600 served in 08/09 and 25,000 in 09/10 needs clarification; what are service units?
- Art Chen will summarize feedback for this report and follow-up items going forward

### Subcommittee 2

- Reporting from the Alameda County Medical Center has improved dramatically; include in highlight (Kay Eisenhower)
- Correction on expended/encumbered amount under Administration/Infrastructure Support (Kay Eisenhower will check)
- More detail to better understand how funds are used under Administration/Infrastructure allocation (future meeting agenda)
- Acknowledge that Measure A allows for more flexibility in spending than other funding streams (for Alameda County Medical Center)
- Clarification on how SB12 funds used by ACMC versus how Measure A funds used for the same purpose; audit report or internal controls related to this issue

### Subcommittee 3

- Bay Area Community Services – more meals provided to a very frail population and medical assessments provided; what portion of population is low-income or indigent? – Louis Chicoine will review

# Subcommittee 4

- Working on completing all reports by next week
- Generally no concerns except for inconsistencies on how information was reported

### Subcommittee 5

- Concern about transparency on process of how funds are allocated or even lack of process;
- Sharp increase in number of allocations noted
- Concern about not spending allocation

# **General Comments**

- Discussion around the charge of the Oversight Committee and whether the role can be broadened;
- Consider sharing comments and concerns with fund recipients, with emphasis on continuous concerns;
- Consider revising form to be more program specific; provide more definition on what is being requested; include question that asks how concerns from previous year have been addressed;
- Better explanation of questions on form.
