# V. 9:30 AM Presentation: St. Rose Hospital FY 2017-2018 Measure A Allocation

- Aman Dhuper began with an overview of St. Rose Hospital (SRH), including their mission, vision and values and statistics of their services. He mentioned that their Dialysis unit is just 12 months old and their Telepsychiatry program is just over 3 years old
- Roger Krissman then went over their budget. He highlighted that because of their programs, their ED visit numbers were reduced in 2018.
- Mr. Krissman noted that their Payor Mix is 88% Medi-Cal and Medicare patients.
- Both Mr. Krissman and Mr. Dhuper highlighted the 5 or 6 years that it took for the PBGC (Pension Benefit Guaranty Coproration) to recognize that SRH was a safety net hospital and took over their pension plan without taking over the hospital.
- Elizabeth Reed-Gonzales highlighted their objectives and noted the great work of the staff, patient surveys being 4 stars and above, and SRH's programs and efforts to streamline their intake so that their patients are properly cared for.
- Ms. Reed-Gonzales gave an overview of the ED Throughput program which showed the time it takes to service a patient. The results were generally showed a reduction in patient wait time.
- Mr. Dhuper went over stipends for SRH and explained the increase in anesthesia costs being contributed to by the way SRH is billed – by units. Anesthesia units are billed at 15 minute increments. The federal government reimbursement rate for these units are \$11.
- Mr. Dhuper also explained the decrease in their radiology costs. They have contracted with a vendor that can work remotely, servicing multiple hospitals at once. This same vendor also supplies on site assistance 4 days a week, as well as on-call service.
