III. Review of Minutes

John Becker moved to adopt the August 27th minutes; motion seconded by Don Sheppard; motion passed.

IV. Review of Materials

V. Consultant Services for Development of Next Report – update

Jennifer Chan reported that the contract with Kring Design services will be reviewed by the Board of Supervisors at an October Board meeting; Kring has offered to attend the next Oversight Committee meeting to discuss the FY 08/09 and 09/10 report development.

VI. Preparation for Presentation from Alameda County Medical Center (ACMC) on October 22

Notable in the FY 09/10 report as submitted by ACMC:

- Page 4 increase in number of visits
- Page 6 #3 under Community /Image Enhancement

FOLLOW-UP QUESTIONS:

- How does ACMC account for other categorical funds received?
- Why can't Measure A funds be differentiated from other funds?
- Does ACMC account for specific activities funded by Measure A? Provide detail, if possible.
- Answer to question #3a shows \$69 million, but \$77 million budgeted for FY 09/10 (as shown in attachment) was there a carry over? What were actuals?
- Question #2d what is included in the 20% of all other? Are they administrative costs?
- Surplus in revenue despite loss in Measure A funds; where does ACMC stand with respect to their loan with the County? (page 6 under Fiscal Stewardship)

Jennifer will forward the Committee's questions the ACMC.

The ACMC presentation will be scheduled for 10am at the next Oversight Committee meeting (10/22/10) and will include a 30 minute presentation followed by a 30-minute question and answer session.

VII. Review and discussion of FY 08/09 Draft Reports – Presentations by Subcommittees

Members of Subcommittees 1, 4 and 5 presented their draft reports.

Follow-up items include:

- For Subcommittee 1 revise last paragraph of Community-Based Organization (CBO) report (Mee Ling Tung will revise), revise Cherry Hill section under the Detox/Sobering Station report (including clarification on wait list total of 4184 (for what time period?)) (Mee Ling Tung will revise); revise #1 under program objective for mental health costs for Juvenile Justice Center report (Mee Ling Tung will revise); Jennifer and Vana will check dollar figures provided;
- For Subcommittee 4 Vana will provide data on number of visits provided and number of clients served
 for the Healthy Communities and Preventive Care Pathways report; Vana will provide additional
 information in the first paragraph of the primary care CBO report regarding total contract obligations;
 Jennifer and Vana will check dollar figures provided and determine if information on the County
 Medically Indigent Services Plan is needed;
- For Subcommittee 5 Jennifer will research the contract with AIDS Alliance-Vital Life services to determine what happened to funds as the agency ceased operations in May 2009; Deborah Pitts-Cameron will follow up with Board offices to obtain more information on how they allocate their discretionary Measure A funds;

Outstanding draft reports should be emailed to Jennifer directly to be forwarded to Kring. Outstanding FY 08/09 reports will not be reviewed by the Committee as a whole, with the exception of the Alameda County Medical Center report.

VIII. Update and Discussion on FY 09/10 Reports

Jennifer reported that 26 of 40 reports had been received.

The Committee agreed to work in the same Subcommittees (as assigned for review of FY 08/09 funds) for the purpose of reviewing FY 09/10 reports.

Jennifer explained that the term of the contract for a FY 09/10 allocation to Las Positas College did not begin April 2010 (near the end of FY 09/10) and asked the Committee if they wanted Las Positas to complete the FY 09/10 report anyway. The Committee asked that Las Positas complete the report to reflect the services provided during April 2010 to June 2010.
