VI. 9:30AM Presentation: FY 14-15 Measure A Expenditures for Alameda Health System & San Leandro Hospital

Presenters: Delvecchio Finley, Chief Executive Officer and David Cox, Chief Financial Officer

- A. A. Net Patient Services Revenue has increased to 66% of total revenue due to more direct reimbursement following full implementation of Affordable Care Act (ACA)
- B. Industry average for Length of Stay (LOS) is 4.0 hours. AHS' previous LOS was about 12 hours. The current 7.8 hours target is a significant improvement.
- C. FY 2015 operating margin is -8.0%.
- D. Current debt is \$137M.
- E. Current year revenue actuals is slightly higher than budgeted with some slight increases in operational costs.
- F. HCAHPS ("H-CAPS") Score used to measure patient satisfaction.
- G. AHS uses Measure A as a supplemental funding source to cover costs that are not covered by reimbursement revenue.

VII. 10:30AM Update from Acting Health Care Services Agency Director, Rebecca Gebhart

The original intent was for Measure A create a permanent supplemental funding source for AHS. Compared to comparable county hospitals that receive supplemental funding directly from their respective counties, Alameda County does not provide a significant supplemental funding source (e.g., from General funds). This is the purpose of bringing Measure A to the voters.
