- Ms. Chan also announced that Dave Kears would be presenting the Oversight Committee's report of FY 04/05 expenditures to the Board of Supervisors on Tuesday, February 27th at 10am in Oakland.

IV. Report on Presentation to Health Committee

- Ms. Chan reported that an article appeared in the Daily Planet on the report to the Health Committee; copies will be provided to Committee members
- Sal Tedesco and Larry Platt shared the following highlights from the Health Committee meeting:
 - Supervisor Keith Carson expressed interest in the timing of the report as it relates to helping the Board make funding decisions for Measure A; encouraged the Committee to complete review of FY 05/06 expenditures as soon as possible;
 - the Health Committee would like to see more regarding what Measure A funds were spent on;
 - the Health Committee would like more information on Measure A expenditures as they relate to the Alameda County Medical Center
 - Dr. Platt explained to the Health Committee that the Oversight Committee intended to refine its review process
 - Dr. Platt expressed the Oversight Committee's interest in understanding how funding and/or contracts are monitored as it related to Measure A funds
- The Committee would like to consider advising the Board of Supervisors on policy issues that need to be considered for the reallocation of Measure A funds (reallocation of funds need to occur for FY 07/08); the Committee requested this be agendized for the next meeting

- Vana Chavez presented and reviewed budget worksheets (for Measure A funds not specifically designated for the Alameda County Medical Center) for FYs 04/05, 05/06 and 06/07
- Mr. Chicoine moved to adopt Option 3 including a more detailed process of review of the Alameda County Medical Center and the Bay Area Consortium for Quality Health Care.
- Motion seconded by Mr. Tedesco.
- Amendment to motion by Peter Manoleas: the Committee shall update reporting format and template in preparation of review.
- Motion passed.
