VII. Draft Press Release and Strategy

VIII. Planning for Next Year's Business

- The following changes were suggested on the reporting form:
 - question #1: request attachment of FY 07/08 approved budget
 - question #7: not clear what information is being requested as written eliminate?
 - question #8: include a request for a description of the impact on specific patient populations (including age, gender, race);
- Regarding the Board of Supervisor allocations, the Committee would like to consider requesting information on whether providers received other Measure A funding and how those funds were used differently; the Committee also raised the question of whether they would like to hear presentations from providers who receive Measure A funds from Board members;
- Kay Eisenhower reported that she received feedback from Vote Health regarding the Alameda County Medical Center portion of the FY 05/06 and 06/07 report; suggestions included greater specificity, information on what specifically would be jeopardized if Measure A funds were not available; data on the percentage of reimbursement per insurance sources versus cost;
- Additional work needs to be done in terms of framing the presentation format for those providers and/or agencies who present to the Oversight Committee (to allow for more consistency);
- The Committee would like more detail from all providers in general;
- The Committee raised ongoing concerns regarding the lack of diversity of the composition of the Oversight Committee and suggested that the Board of Supervisors (BOS) request 2 nominees for each position allotted to a community group or agency with the BOS making the final choice from those nominees in hopes of improving the diversity of the Committee; the Committee requested that this suggestion be made at the Health Committee meeting to be forwarded to the BOS;
- The Committee requested that review (and possibly approval) of the FY 07/08 report form be placed on the agenda for the next meeting
- HCSA indicated that they would prepare the reconciliation of the FY 07/08 budget for the next meeting.
