• Jennifer Chan reviewed the materials provided, which included:

- 3. Spreadsheet summarizing FY 04/05 through 06/07 budgeted revenue and actual expenditures.

IV. Announcements

- Kay Eisenhower informed the Committee of an article in the San Francisco Chronicle on September 27th regarding the impact of dirty emissions at the Port of Oakland and its effect on residents in West Oakland; Dr. Tony Iton of the Public Health Department is quoted in the article describing the negative health impacts on the community; Kay inquired as to whether any Measure A funds were spent on studying and/or remedying this issue; Dave Kears informed the Committee that Measure A funds were not spent for that purpose;
- Jennifer Chan informed the Committee that Ron Silva has resigned from the Committee and that Supervisor Lai-Bitker is in the process of finding a new appointee;
- Jennifer also announced that the Health Care Services Agency (HCSA) is preparing to release a request for proposals (RFP) for Measure A capital funds for community-based organizations in Alameda County that provide health services; the RFP will be reviewed and likely approved at the Board of Supervisors meeting on October 9th; the RFP application materials will be available at the HCSA website following approval by the Board;
- Kay Eisenhower inquired about the status of the reappointments for members whose terms will be ending on October 31st; Jennifer Chan explained that all but 2 members whose terms will be ending would like to continue their service on the Committee; the remaining 2 members have agreed to stay on the Committee until the completion of the next report; the County Board of Supervisors needs to formally approve the appointments and Jennifer will be submitting a Board letter to this effect
- Jennifer announced that the request for the 06/07 written reports were sent out to fund recipients in September, with a submission deadline of October 5.

V. Presentation re: Bay Area Consortium for Quality Health Care

The Bay Area Consortium for Quality Health Care (BACQHC) presented on their
written report of FY 05/06 expenditures and discussed with the Oversight Committee
its ongoing issues with the County. Clarification was provided to BACQHC that the
Oversight Committee was not authorized to approve or disapprove specific
allocations, but rather to review past allocations for conformity with the provisions of
the initiative.
